Farewell to M. G. George Muthoot, Group Chairman, The Muthoot Group of companies (1949-2021)



The untimely demise Mr. M. G. George Muthoot, Group Chairman of The Muthoot Group of Companies on 5th March, 2021, marked the end of an illustrious journey that had catapulted Kerala to the top of the NBFC chart of India. Forbes Asia Magazine had listed him as the 50th richest man in India in 2011 and his ranking climbed to 44th richest in India according to Forbes' India's Richest list 2019 and as per the Forbes' Rich List 2020, he was the richest man in the state of Kerala.

Mathai George George Muthoot aka Joychayan for his close firends and associates, was born in November 1949 in Kozhencherry as the son of Mr. M George Muthoot, who began the finance business and as the grandson of Mr. Muthoot Ninan Mathai, the group founder. He joined the Muthoot family business at young age and rose to become the Managing Director of The Muthoot Group in 1979 and consequently, became the Group Chairman in 1993, a position he led with until his very last day. At the time he took over the operations at Muthoot, the Group had just 31 branches in four states, and today the Group has nearly 5000 branches. Mr. M. G. George Muthoot was a member of the executive committee of the Federation of Indian Chambers of Commerce and Industry (FICCI), and the he was the Chairman of the FICCI Kerala state Council.

Well known for his visionary and value driven leadership role Mr. M. G. George Muthoot helped The Muthoot Group expand to new beights of growth and become the market leader in Gold Loan Industry. He propagated to run a value driven culture at The Muthoot group which has six core values: Ethics, Values, Reliability, Dependability, Trustworthiness, Integrity, and Goodwill, on which the organization is built. Mr. M. G. George Muthoot was awarded the Mahatma Gandhi National Award by the Mahatma Gandhi National Foundation in 2001 for his contributions to the Indian industry and he also received the Golden Peacock Award for Corporate Social Responsibility.

His sudden and unexpected demise will be an irreparable loss to the employees, all stakeholders, family, his numerous friends and to the State of Kerala.

About three years ago, a rather telling photograph was taken of the four brothers of Kochi-based The Muthoot Group. The picture, according to M G George Muthoot, the eldest of the four brothers, shows the unity and strength within the family. The photograph is of M G George, 67, with George Alexander, 61, managing director, and joint managing directors George Thomas, 66 and George Jacob, 64. The four brothers represent the 19th generation of the Theverveil family (now known as the Muthoot family) in Kerala's Kozhencherry that has a business legacy of over 800 years.

But it's not just about family bonding.

M G George Muthoot says the photograph is also a reflection of how the brothers have bonded with the group's 35,000 employees: "We treat them as if they're our own. We stand shoulder to shoulder with the last man in the system... We are like the generals who fight wars alongside their soldiers at the front, and not from a bedroom shouting 'fire'."






